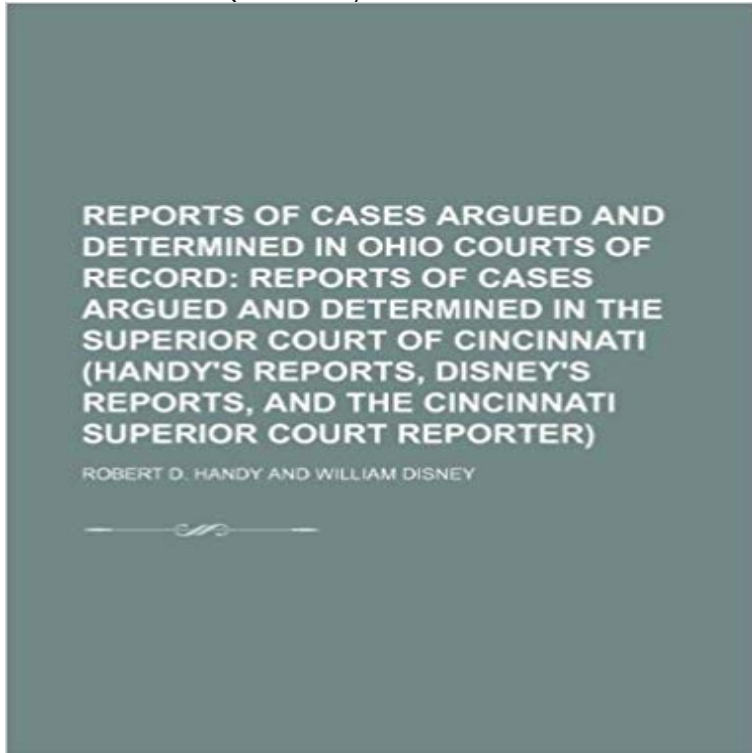

This case has been reserved on the questions arising on a demurrer to the petition, and amended petition of the plaintiff. The inquiry is, whether the matters set forth in the petition constitute a cause of action, whether in respect thereof as stated in the petition the plaintiff is entitled to any relief? If the plaintiff be entitled to some relief, upon the facts stated, the demurrer cannot be sustained. This is a liability created by statute, and we must look to the statute to see what is essential to its creation. Section 26 of the municipal corporation act in general terms confers power upon the proper authority of each municipal corporation to improve streets, and to assess a charge on the owners of lots, or on the lots through or by which the street may pass. A municipal corporation is authorized to provide either by a general or special by-law as to the mode in which this charge shall be assessed and determined; (Section 30.). Such charge may be made payable to the municipal corporation, or to any person it may direct, and may be collected in the name either of the municipal corporation, or of such person. In any such proceeding at law, where pleadings are required, it shall be sufficient to declare generally, for work and labor done, and materials furnished on the
